VENUE:

The Conference Center at the Washington State Convention Center 800 Pike Street, Seattle, WA 98101

The Conference Center is located right in the heart of downtown with easy access to Interstate 5, convenient parking, the airport light rail link and the many great things Seattle has to offer.

DIRECTIONS AND PARKING:

From I-5 Southbound to Convention Center Garage (Primary entrance on 8th Avenue)

- I-5 Southbound, take Stewart Street Exit (#166)
- Left on Boren Avenue
- Right on Seneca Street
- Right on 8th Avenue
- Garage entrance is on your right
- From I-5 Northbound and I-90 Westbound to Convention Center Garage
- I-5 Northbound, take Madison Street Exit (#164A)
- Right on Madison Street
- Left on 8th Avenue
- Garage entrance is on your right

Convention Center parking is located in close proximity to two I-5 exits and is accessible from the eastside of the freeway. The Conference Center entrance is on the north side of Pike Street and 8th Avenue. No parking validation is available for WAEPS program participants.
