Dr. Fountain is a Professor at Rush University Medical Center in Chicago. She lectures on reconstructive and cosmetic eye surgery at various scientific meetings and across the country and abroad. Currently she is Chair of The Board of Ophthalmic Mutual Insurance Company (OMIC) and Secretary for Member Services for the American Academy of Ophthalmology.

Srinivas Sadda, MD is the President and Chief Scientific Officer of the Doheny Eye Institute, the Stephen J. Ryan – Arnold and Mabel Beckman Endowed Chair, and Professor of Ophthalmology at the University of California – Los Angeles (UCLA) Geffen

School of Medicine. He received his MD from Johns Hopkins University, where he also completed ophthalmology residency and neuro-ophthalmology and medical retina fellowships (Wilmer Eye Institute).

Dr. Sadda's major research interests include automated retinal image analysis, retinal substructure assessment, and advanced retinal imaging technologies. He has more than 380 peer-reviewed publications and 13 book chapters and has given over 350 presentations worldwide. He is also an editor of the 5th edition of the Ryan's Retina textbook. Among Dr. Sadda's awards and honors are a Research to Prevent Blindness Physician-Scientist Award, a Senior Honor Award from the American Society of Retina Specialists, an Achievement Award and a Secretariat Award from the American Academy of Ophthalmology, John H. Zumberge Research and Innovation Award, the Macula Society Young Investigator Award, Asia-Pacific Academy of Ophthalmology (APAO) Achievement Award, The Macula Society Paul Henkind Lecture and Award, and American Society of Retina Specialists Young Investigator Award. He has also received the Silver Fellow designation from the Association for Research in Vision and Ophthalmology.

Mitchell A Jackson, MD



Mitchell A Jackson, MD, is the Founder and CEO of Jacksoneye, his private practice of 27 years located in Lake Villa, Illinois. He graduated from Pomona College, completed his medical training at FUHS/The Chicago Medical School, and completed his Ophthalmology residency at the University of Chicago Hospitals. He serves on the editorial boards of Cataract and Refractive Surgery Today, Ophthalmology Management, Advanced Ocular Care, and Ocular Surgery News. Dr. Jackson is also a board member of the American College of Eye Surgeons (ACES), founding member of the American College of Ophthalmic Surgeons (ACOS), and founding member and past 2018 President of the Cataract External Disease and Refractive Surgery Society (CEDARS/ASPENS). Dr. Jackson has been involved in many FDA pharmaceutical and surgical clinical studies (Dry Eye, Viscoelastics, IOLs, Presbyopia, topical NSAIDs) over the tenure of his practice, including serving as the Global Medical Director of ACE Vision Group. He also has his own monthly column entitled "The Premium Channel" in Ocular Surgery News/Healio which launched in April 2013. He recently was the recipient of the 2018 Annual Millennial Award, the AAO Board of Trustees Achievement Award in August of 2018, the 2018 Innovation and Founders Award for Cedars Spens, and the 2020 Albert Nelson Marquis Lifetime Achievement Award for Ophthalmology.
